### PROJECTS: PROP 68 WATER PROJECTS UPDATE

Ms. Lindeman reported to the board that See's Engineering had completed all drilling and percolation testing for the Crane site. Two 50' and 15' borings had been completed on the Johnson site and finishing up with the percolation tests today.

Ms. Lindeman stated that See's encountered a 30-40' thick layer of sand at the Johnson site on both deep boring locations. They have already started laboratory tests.

Scott Jacobson from Summers Engineering authorized See's to perform soil profiles on additional locations on the Johnson property that Director Johnson was excavating in the same area.

# GROUNDWATER SUSTAINABILITY AGENCY UPDATE

Ms. Lindeman reviewed with the board the MSGSA Allocation Timeline. January 2026 is when MSGSA is planning to implement the Allocation Policy, Fee Structures and Penalties. There are currently eight different sustainability zones that will all be managed differently depending on their 2015 groundwater elevation data. The majority of AWD lands falls within Zone 2, besides 235 acres of Director McNab's. Ms. Lindeman explained to the board that she will work with Director McNab and submit to MSGSA a reclassification of her 235 acres, making the entire AWD in the same zone.
