# **GROUNDWATER SUSTAINABILITY AGENCY (GSA): UPDATE**

Mr. Samuelson presented a very thorough GSA report for the Merced Sub-basin and reminded the board that the Groundwater Sustainability Plan must be turned into the State by the end of the year.

## **DATA MANAGEMENT: UPDATE**

Mr. Samuelson reminded the board that the data collection effort for all facilities within the District boundaries will be very valuable information moving forward. The goal is for all the District landowners to work together on the accuracy of the data and access to the facilities so staff can document efficiently and effectively. He also stated that as a public agency, this data is now available to the public if so requested.

Mr. Gardner proposed the following data collection intervals: Groundwater Elevations-March and September Deep Well Pumping-Monthly Surface Water Deliveries-Monthly Crop Data-Annually

The board acknowledged that the schedule looked good and they would work closely with Mr. Gardner to make sure he had access across their properties for data collection purposes.
